DIRECTIONS:

Seal with Mohawk E-Z® Vinyl Sealer (M102-8000). Highlight guitar as desired. SHAKE WELL for one minute after agitator ball rattles. Apply full wet coats with overlapping strokes. Clean spray button. Dry at least 1 hour. Repeat application and dry cycle up to 3 times in one day. Dry overnight. Scuff sand. Repeat until 9-12 coats are applied. Wait at least 1 week after last application. Rub as desired.
