If more is needed it can be added up to 4.5% by volume, 6.0 oz per gallon. EnduraGreen® Extender does reduce the viscosity, adjust equipment if needed.EnduraGreen® Extender can be used in VOC regulated areas and will remain in compliance if used according to directions, 6 oz per gallon max level.
