Remover No. 2 is effective on lacquers, varnishes, shellacs, catalyzed finishes, polyurethanes and other finishes. On some difficult to remove finishes, several applications of remover may be necessary. Remover No. 2 does not contain either acids or caustics that require subsequent neutralization before finishing can be done. Recommended for cleaning paintbrushes. Soak brush, then rinse clean with warm water.

<u>Advantages</u> May be washed off with water.

Specifications: Always use splash proof face shield, rubber gloves, neoprene apron and respirator with Remover No. 2. Remover No. 2 is ready for use as received in the can; no reduction of any kind is necessary.

Directions: Shake can well before using to insure homogeneous mixture. Flow on thick uniform coat from full brush, brushing only in one direction. Do not brush back and forth as when painting as this leaves holes in the film. Let remover do the work. Wait until test scraping indicates old paint is ready for removal. Remove with scraper, steel wool or with burlap. Wash the stripped surface with warm water and or M710-2007 Stripper Wash to remove residual wax before refinishing. Use brass bristle on open pored wood to remove wax residue.

Clean up with Mohawk Lacquer Reducer M650-010 or S-15 Reducer M650-250.
