Mohawk Seal & Stain[™] Pre-Stain/Clear Stain Base builds a platform for the subsequent finishes. This allows the stain to penetrate only to a certain depth and therefore gives uniformity to the finish. Seal & Stain[™] Pre-Stain/Clear Stain Base may also be tinted with Mohawk Base Concentrates (M500), Mohawk Xpert® Colorants (M844) and Mohawk Universal Colors (M562) to create custom stain colors or added to M545 or M547 wiping stains to reduce color intensity. Note: Bases are short filled to accommodate colorant.

Directions: To use as a pre-stain treatment of wooden surfaces to reduce blotchy areas in soft woods before staining: Sand wooden surface with 150 or 180 grit sandpaper. Apply by spray, brush or rag liberally over entire surface and remove excess

by wiping with a cloth. Allow Seal & StainTM Pre-Stain/Clear Stain Base to dry 15-30 minutes before applying any M545 or M547 stain color. Best results are achieved if the stain is applied within 12 hours.

To use as a clear stain base with colorants to mix custom colors: Stir or shake thoroughly before adding colorants. Up to 20% by volume of Mohawk Base Concentrates (M500), Mohawk Xpert® Colorants (M844) or Mohawk Universal Colors (M562) may be added to Seal & StainTM Pre-Stain/Clear Stain Base to create custom stain colors. Seal & StainTM Pre-Stain/Clear Stain Base may also be added to any M545 or M547 wiping stain to reduce color intensity. Apply the custom color Seal & StainTM by cloth, brush or spray and wipe to desired color. Allow the stain to dry for 30 minutes before applying Mohawk sealers and topcoats. Not for use as a reducer or pre-stain for the M520 Series Ultra Penetrating Stains.

Custom color blends of the XpertTM Stain Base are suitable for all interior wooden surfaces and may be sealed or topcoated with all Mohawk Professional Finishing SystemsTM (PFS).
