## **Specifications:**

Directions: This is a VOC compliant product. No reduction is necessary. Seal with Mohawk Finisher's Choice<sup>TM</sup> Clear Lacquer Sealer (M610-2500), and allow to dry for 30-45 minutes. Sand thoroughly with 280-320 grit stearated sandpaper, and remove dust before topcoat application. Apply in light, even coats of no more than 3-4 wet mils. If a second coat is desired; scuff sand with 320 grit stearated sandpaper. Total film build of the entire system, including topcoats, should not exceed 4 dry mils. Excessive build may lead to poor adhesion, cracking or cold check problems. Second and third coats are optional (total dry film should not exceed 4 mils). If sanding between coats is desired, use 280 or finer grit paper and remove dust before topcoating. If finish is to be rubbed, 3 coats may be necessary. Mohawk Finisher's Choice<sup>TM</sup> Clear Lacquer is a VOC compliant product that is manufactured at spray viscosity and does not require reduction. Introduction of additives or reducers may cause the product to exceed VOC limits. Mohawk Lacquer Reducer is recommended for equipment clean up.

**Note:** Total film build of the entire system, including topcoats, should not exceed 4 dry mils. All products should be stirred properly before being used and also continuously agitated while in use to insure product consistency from start to finish. Filtering at every opportunity is suggested. The system should be pre-tested on the wood to be finished under application conditions. Mixing with other products or finish systems is not recommended. Mohawk Finishing Products will not be held liable for finish failure resulting from mixing products or systems. This product is formulated for interior applications and is not recommended or tested for exterior use.
