## **Specifications:**

Directions: SHAKE WELL BEFORE USING to ensure color and sheen uniformity. Point opening of spray button toward object, holding can 12 to 14 inches away from surface to be coated. Press spray button firmly. Clean spray button immediately by spraying with can upside down until no more product comes out. If clogged, remove spray button with a twisting motion and clean. Gently twist button onto can with opening turned away from you.

Note: Recommended for use with most solvent based coatings, NGR stains, toners and solvents. Manufacturer has only filled solvent and propellant. For more specific information, please reference MSDS of material filled. Always test first can filled in an inconspicuous area to ensure desired performance.

### **Safety Cautions:**

Principle Hazards: Danger! Extremely flammable liquid and vapor. Vapors may cause flash fire. Causes Eye and skin irritation. Harmful if swallowed. Vapor harmful.

Other Hazards: Causes eye, skin, nose and throat irritation. Do not smoke. Extinguish all flames and pilot lights, and turn off stoves, heaters, electric motors and other sources of ignition during use and until all vapors are gone. Do not get in eyes, on skin or clothing. Vapors may ignite explosively. Do not breathe dust, vapors or spray mist. Keep away from heat, sparks and flame.
